

Kent Nutrition Group, Inc. CONTEST

OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. CONTEST BEGINS AT 12:00:01 AM PT ON August 5, 2026 AND ENDS 11:59:59 PM PT ON August 31, 2026.

1. WHO CAN PARTICIPATE (ELIGIBILITY): This Contest ("Contest") is open to individual legal residents of the 48 contiguous United States and Washington, D.C. who are age 18 or older as of date of participation (or considered an adult in the jurisdiction of residence). Employees (and their immediate families and members of the same household) of Sponsor (defined in Rule 9 below), and their respective subsidiaries, affiliates and advertising and promotion agencies, and each of these entities' respective officers, directors, managers, shareholders, employees, agents, representatives, successors and assigns (collectively, the "**Released Parties**") are not eligible to enter or win the Contest.
